As an organization, we do not offer academic scholarships...instead we offer comfort and financial assistance to special needs children.

The Fideliants of America was born in 1939, when four Italian business men met at the Alexander Hamilton Hotel in downtown Paterson, NJ. Their aim was to distribute free milk to needy children throughout the city. As membership increased, war was also looming, and many members were called to service (1939-1945). Those Fidelian Brothers left behind became involved in the war effort by holding bond rallies in Paterson. They raised a considerable amount of money, more than enough to purchase a B-24 Bomber named "The Fidelian".

In 1975, we purchased our camp property in North Haledon. Over the years, many groups have enjoyed our facilities. **All is gratis!** Unfortunately, with so many needing our assistance, the two major fundraisers that we hold annually are no longer sufficient to sustain our giving.

Two thousand fifteen (2015) saw the formation of the Fideliants Foundation Inc. We developed an EXECUTIVE OUTREACH GROUP OF ITALIAN AND CORPORATE BUSINESS ENTREPRENEURS supporting the Foundation. Our purpose was two-fold: to showcase Italian and Corporate Businesses and how they were playing an active role in giving back to the community.

It is our mission to make a difference in the lives of those less fortunate and disadvantaged. We believe that by aiding young people with disabilities, we can empower them to reach their full potential for personal development.
